Overview

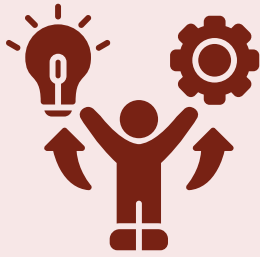
The PSC (Public Finance) Scholarship aims to develop individuals in economics, finance, accountancy or related fields for Public Service leadership positions, particularly those which require strong grounding in Public Finance.

You will be placed on the Public Service Leadership Programme (PSLP) upon graduation, with the Ministry of Finance (MOF) as your parent agency.

You will gain exposure to strategic and policy work which cut across the Whole-of-Government, and functional domains in Finance, Tax, Investment, Audit, etc., through postings to MOF, the Accountant-General's Department (AGD) and the Auditor-General's Office (AGO).

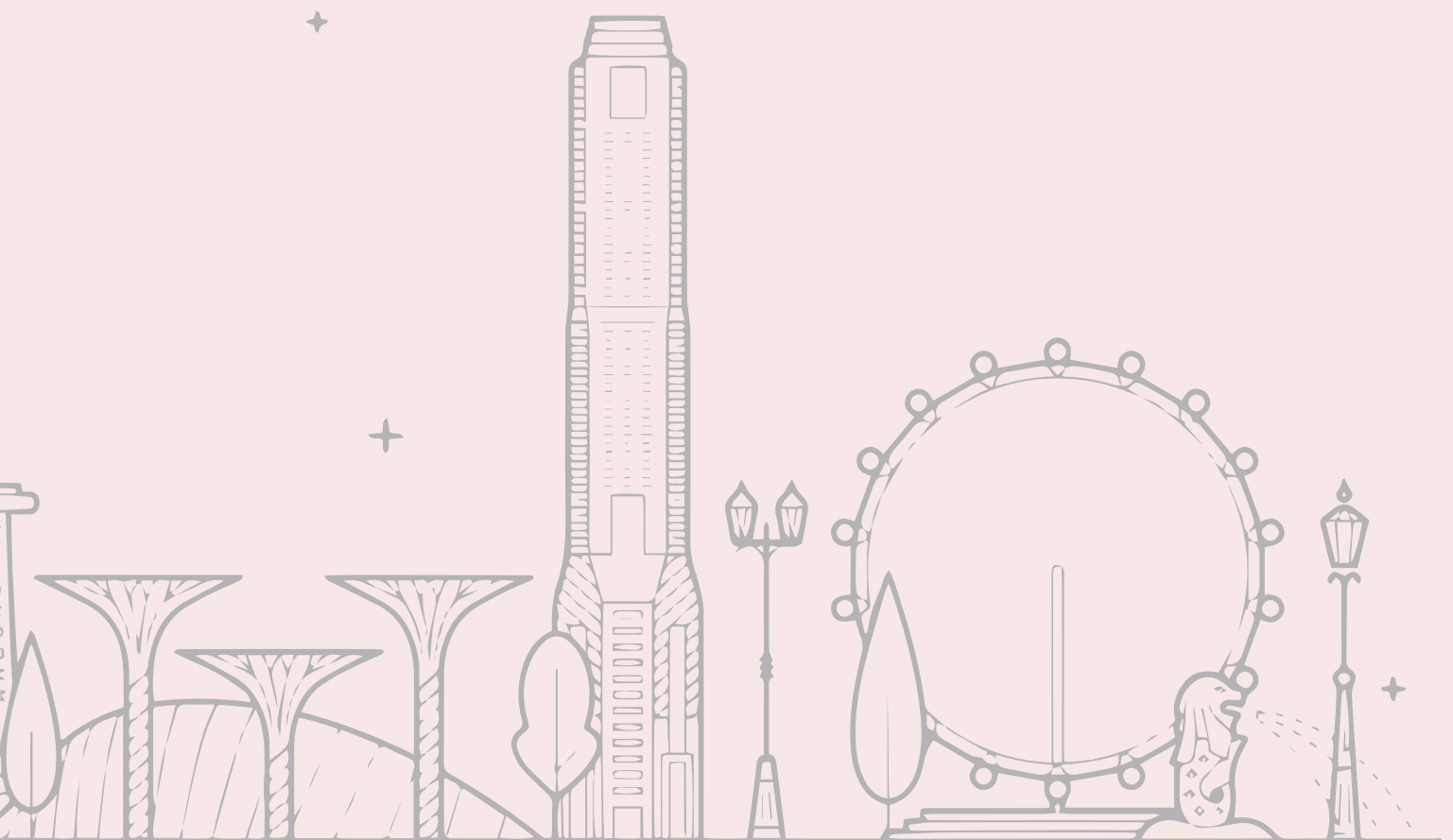

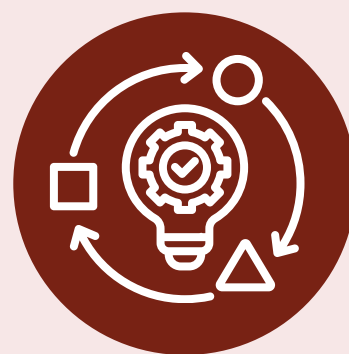

Frequently-Asked Questions



What are the differences between a PSC Scholarship and a PSC (Public Finance) Scholarship?

The PSC (Public Finance) Scholarship caters to students with a career interest in Public Finance (e.g. Fiscal Policies, Reserves, Investments, Tax, Finance, Audit).

You will be assigned to MOF as your parent agency, with stints in AGD and AGO, and other agencies in the public service to provide you with all-round exposure. There will be tailored opportunities for you to review strategic Whole-of-Government issues and cultivate a Centre-of-Government perspective; hone economic policy-making skillsets, quantitative and analytical rigour while considering public sentiments, leverage data and synthesize information to support evidence-based decision-making.

Frequently-Asked Questions



Can I pursue overseas studies under the PSC (Public Finance) Scholarship? What are the courses of study that are supported under the scholarship?

The PSC (Public Finance) Scholarship is tenable for local or overseas studies. The courses of study supported under the scholarship include recommended disciplines such as Accounting, Analytics, Business, Business Administration, Business Management, Economics, and Finance.



What are the eligibility criteria for the PSC (Public Finance) Scholarship?

Applicants should:

- Be a Singapore Citizen;
- Demonstrate strong leadership qualities;
- Possess good academic and non-academic/ co-curricular activity (CCA) records;
- Have GCE 'A' Levels, International Baccalaureate, Polytechnic Diploma with merit, NUS High School Diploma, or other high school diploma or equivalent; or
- (For mid-term applicants) Currently undertaking undergraduate studies in Accounting/ Analytics/ Business/ Business Administration/ Business Management/ Economics/ Finance with at least one semester of university results and not in the final year of undergraduate study.
