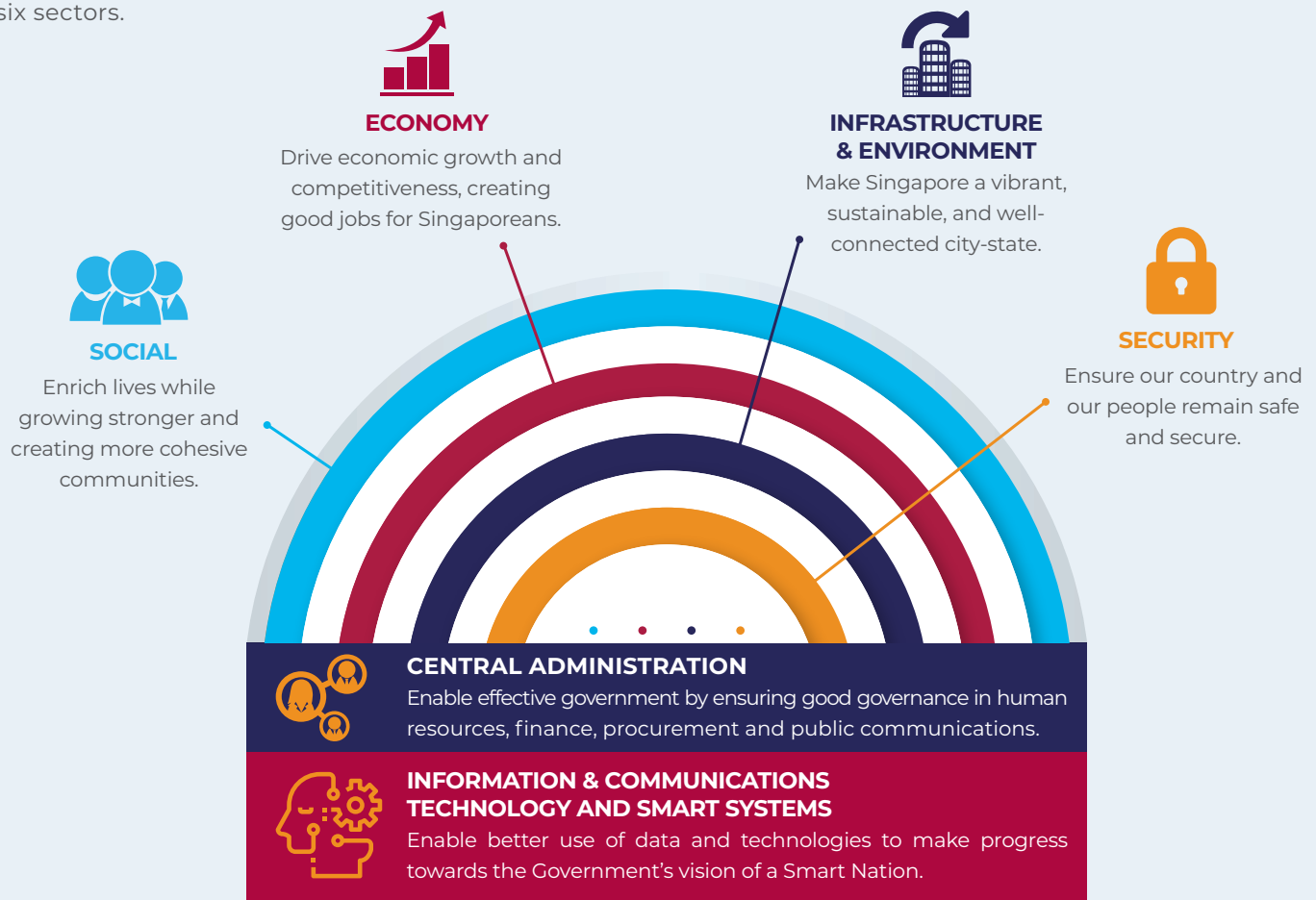


The Singapore Public Service

- The Singapore Armed Forces (SAFS)
- The Singapore Police Force (SPFS)

Development Programmes and Opportunities

Before beginning their undergraduate studies, PSC scholarship holders undergo their first development programme: a Preparatory Course that prepares them for their role as future public officers.

During their first and second years of undergraduate studies, scholarship holders are equipped with the necessary knowledge, skills, and experiences to lead change in their communities through the PSC's partnership with Youth Corps Singapore (YCS).

At the end of their second year of undergraduate studies, scholarship holders take part in a 6-8-week internship with a government agency as part of the PSC Scholarship Holders' Mid-Course Programme (PSMP).

In addition to both overseas and local academic programmes, scholarship holders also have the option of pursuing a Master's Degree, and the chance to work in the private or people sector through a 6-month to 1-year Gap Year Programme.

Public Service Leadership Programme (PSLP)*

A structured programme focused on cultivating and developing talent.

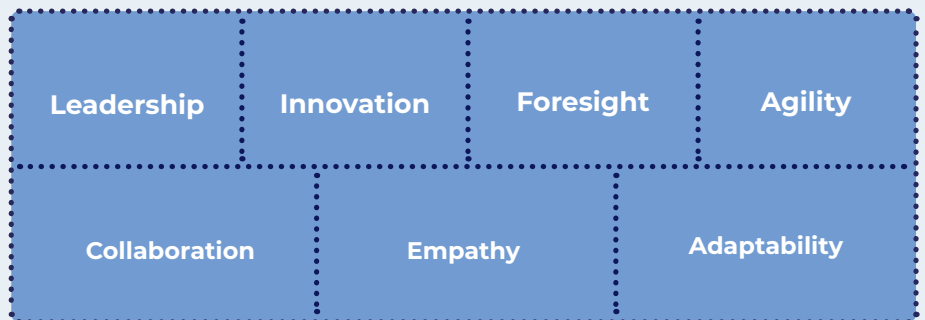


*Directly applicable to the PSC Scholarship and the PSC Master's Scholarship. Those on the Professional Service path, except for PSC Scholarship (Medicine or Dentistry) and (Legal Service) recipients, will be offered different career pathways under the General Phase of the PSLP. Those on The SPF Scholarship will be put on the PSLP (Home Affairs Uniformed Services). Those on The SAF Scholarship, PSC Scholarship (Legal Service) or (Medicine or Dentistry) will be put on a separate talent programme.

What We Are Looking For



Apart from integrity and the heart to serve, aspiring PSC scholarship candidates should possess the following qualities:



Eligibility Criteria

- Be a Singapore Citizen.
- Have strong leadership qualities and potential.
- Have good academic and co-curricular activities (CCA) records.

PSC UNDERGRADUATE SCHOLARSHIPS

- GCE A-levels; or
- International Baccalaureate; or
- NUS High School Diploma; or
- Polytechnic Diploma with merit; or
- Other high school diploma or equivalent.

You may apply prior to receiving your final examination results. A provisional scholarship offer may be made if you are found suitable, subject to confirmation upon release of final results.

PSC UNDERGRADUATE SCHOLARSHIPS [MID-TERM]

- GCE A-levels; or
- International Baccalaureate; or
- NUS High School Diploma; or
- Polytechnic Diploma with merit; or
- Other high school diploma or equivalent; and
- At least one semester of university results.

Application should be made before the final year of your undergraduate studies.

For professional schemes with a tied agency, you must be undertaking an undergraduate degree in an area that is relevant to the tied agency.

PSC MASTER'S SCHOLARSHIP

- Current final year undergraduate; or
- Recent graduate with no more than 3 years of working experience (incl. part-time, contract basis) in the private/non-government sector only.
- Be prepared to start in the immediate Academic Year following the scholarship offer.

Current Public Service officers (incl. those on probation) are not eligible. Officers should contact their agencies' HR for post-graduate sponsorship opportunities.

Step Up to Serve Singapore

As a PSC scholarship recipient, an enriching and purposeful career awaits, where you will have opportunities to shape Singapore's future.

[^] For The SAF Scholarship, the total duration of study is 4 years for English-speaking countries and 5 years for other countries. The duration of bond is 6 years, regardless of the country of study.

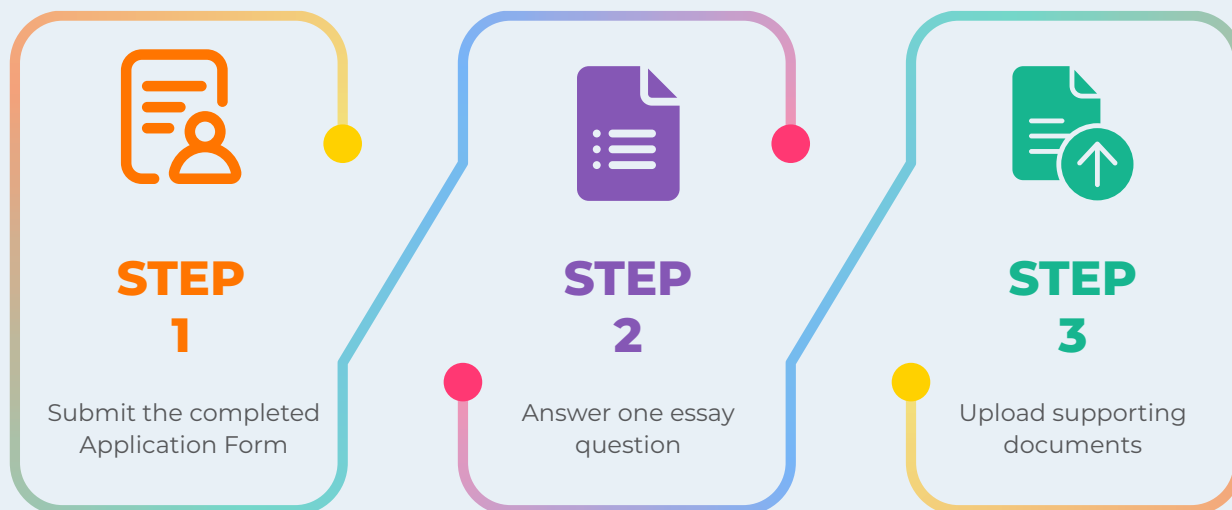

Use this checklist to ensure that you have prepared all the information and documents* required to complete your submission.

- ☐ Schools attended and period of studies
- ☐ CCA and Community Involvement Programmes (CIP) records
- ☐ Achievements, prizes and awards received, Public Sector internships
- ☐ University applications and outcomes
- ☐ NS Certificate of Service (if applicable)

Mid-Term and Master's Scholarship Applicants will also need to prepare:

- ☐ Latest University transcript
- ☐ Latest University CCA records
- ☐ Employment testimonials (if applicable)

Optional Documents:

- ☐ Testimonials from Public Sector internships
